I. <u>Call to Order</u>

V. Building Goal Presentations

Mr. Weber reviewed the 4 goals of the District in the areas of Teaching and Learning, Climate and Culture, Communication, and Financial Stewardship. Building Principals led the Board through highlights of building goals that support the District Goals.

VI. Board Committee Reports

Finance Committee – Mr. Meis reported that the Finance Committee had met earlier in the evening and discussion topics included a review of the Five Year Forecast. The committee reviewed revenue assumptions, including property tax, income tax and state funding with specific review of millage rates and property values. After revenue, the committee reviewed expenditure assumptions including personnel, purchased services, materials and supplies, capital outlay and various fixed costs such as the \$500,000 fees paid to the State of Ohio for income tax collection.

Citizen's Advisory Committee – Mrs. Broderick reported that Mr. Weber gave a presentation to CAC on the State Report Card. Mr. Weber shared that the three study groups of CAC continue to work on their projects: Strategic Planning Process, Graduate Follow-up Survey, and School/Community Partnerships.

VII. Superintendent Committee Liaison Reports

Business Advisory Committee – Mr. Weber reported that the HCESC Business Advisory Council met with the meeting focused on the partnership with Great Oaks, including the expansion of the Laurel Oaks facility, the 2019 Great Oaks report card, and instructional leadership teams.

Community Engagement – Mrs. Yee reported on board member attendance at various events including the WSMA Beats, Eats and Treats event, Athletic Boosters meeting and Wyoming School Foundation meeting. Mr. Thomas reported that the Wyoming School Foundation meeting included discussion of the

District Report Card, the District's work on diversity and equity, CAC study topics, and planning for both the WHS Research/Innovation Center and the Athletic Champion Center.

Planning & Goal Setting – Mr. Weber provided an update on the Athletic Champion Center, including a meeting with residents to provide input and continued work with the City of Wyoming.
